NYC VACATION HOME RENTAL AGREEMENT

This agreement, executed this (date) day of (month, year), A.D. in consideration of the following covenants, agreements, limitations and conditions entered into by the parties hereto for themselves, their heirs, successors, legal representatives and assigns Jimmy Rooben Heardoon does lease unto (name of tenant(s)) herein jointly, severally and collectively called "tenant". The self-catering apartment located at 94 Avenue C, Apartment (unit number), New York, NY, 10009. Furnished: Yes. Bedrooms: (2 or 3 depending on apartment). Bathrooms: 1. Phone: (telephone number for the apartment).

Security deposit to be refunded within 2 weeks after departure. Any damage charges or excessive cleaning charges will be deducted from the security deposit.

To be occupied only as an immediate domicile unless written consent of landlord to occupy for other purposes is first obtained, for the term commencing on the (date) day of (month), 20__, ending no later than 11:00 A.M. on (date of departure). Rent is \$ (rent rate) plus New York City and State taxes. Total Rent is \$ (total rent amount). Departure cleaning is included 4 hours of cleaning and laundry. Water and electric: Included. Internet wireless: Included. Air conditioning/Heating: Included. Phone (telephone number for the apartment). Local Telephone Service: Included.

Received \$ (amount received thus far). Total rent of \$ (balance due) to be paid by (deadline date for final payment). The apartment is rented on a first come first serve basis. Reservations are not confirmed until the reservation deposit is received and guest agreement is received. A second payment of \$ N/A is due on or before 30 Days Before Arrival. Departure cleaning is \$ N/A due on or before N/A. Refundable security deposit of \$750.00 cash or travelers checks due on arrival or in advance by Pay Pal or credit card. The \$750 security deposit will be refunded within two weeks provided the suite is maintained properly. However, in the case of improper maintenance and/or damage, the \$750 security deposit will be held.

Check in time is between 3:00 P.M and 7:00 P.M. (EST: New York Time). Checkout no later than 11:00 A.M. If you need to check-in and/or check-out outside of aforementioned normal business hours, an extra \$75 - \$150 fee will be charged depending upon the time of day and the day of the week. Arrangements for late check-in and/or check-out must also be made prior to arrival.

Providing always, and the tenant hereby agrees as follows:

To make any and all repairs to the said premises, plumbing, fixtures, wiring, etc., when the damage was in any wise caused by the fault of negligence of said tenant, will at the end of this lease surrender and deliver up said premises, without demand, in as good order and conditions as when entered upon: loss by fire, inevitable accident, ordinary wear and decay, only expected. Any damage will be deduced first from the security deposit. It is the landlord's right to determine the damage and costs of repair, if any.

To pay any damages charged above the \$750 security deposit within 15 days of notification of said charges.

That in the event the premises are destroyed or so damaged by fire or other unavoidable casualty as to be unfit for occupancy, then the rent hereby reserved, or a fair and just proportion thereof, according to the nature and extent of the damage sustained, shall, until the said premises shall have been rebuilt or reinstated, be suspended and cease to be payable, or this lease shall, at the election of the landlord, thereby be terminated and ended, provided, however, that this agreement shall not be construed so as to extend the term of the lease or to render the landlord liable to rebuild or replace the said premises.

To permit the landlord or his agent at any reasonable time to enter said premises or any part thereof for the purpose of exhibiting the same or making repairs thereto.

To pay all charges used on said premises per agreement herein; not to hold the landlord responsible for any delay in the installation of electricity, water, gas, phone, Cable TV, Internet or meters thereof, or interruption in the use of such commodities.

To pay any charges over the allowances indicated above.

Not to use the premises or permit the same to be used for illegal, immoral or improper purpose; not make or permit to be made, any disturbance, noise or annoyance whatsoever detrimental to the premises or the comfort and peace of the inhabitants of the vicinity of the premises.

Repairs: The tenant is responsible to notify the landlord of any dangerous situations. The landlord is responsible to correct the problem within a reasonable time. Air conditioners, Heaters, Phone, Cable TV, Internet and appliances are not guaranteed. There will be no refund due to their failure. We try to keep them in good working order.

Substitution or a full refund will be provided in the event the owners elect to change the status of their property.

No pets of any kind are allowed unless specifically approved in writing by the owner.

No smoking is allowed in the building. Smoking is allowed in the garden. Occupancy may be terminated with no refund of rent or security deposit should smoking occur in the building.

The apartment and facilities are for the sole use of the tenants listed on this Rental Agreement. No parties, functions, weddings, reunions, meetings or gatherings of any kind are allowed unless prior written approval is obtained from the owner. Occupancy will be immediately terminated with no refund of rent or security deposit should an additional guest(s) stay in or use the facilities of this rental unit.

Any dispute that may arise will be settled by arbitration in New York City.

It is further understood and agreed between the parties hereto this lease is only valid upon signature and receipt of at least half the total payment. This lease is not cancelable and the rental deposit is not refundable. In the event that this lease (original), is not signed and received by N/A and the balance of funds due is not received by N/A, then this lease shall be considered null and void, and the initial deposit shall be forfeited. Travel insurance is available and suggested. If the apartment is re-rented the landlord will refund a prorated proportion of the rent minus expenses. The costs of re-keying the apartment(s) will be withheld from your security deposit if all keys are not returned.

If you need to check-in or out outside normal business hours a fee will be due and payable to the agent at such time.
